The **minutes** from last month as printed in the newsletter were **approved** with appreciation.

**Treasurer's report** was presented and accepted. Last month meeting approved increasing donations this year. Jay and Wendy will continue to work on how facilitate the meeting moving forward on this.

**Spiritual Care Committee:** The draft of the *State of Society report* was shared. This does not need our final approval until next month. We noted that the recent death of member Kathe Burt and the memorial held yesterday for her need to be included.

A handout on *COVID-19* (Coronavirus) precautions was shared with Friends this morning. We will forgo our practices of shaking hands and passing around the microphone that aids Ruth McNeill. We will put it on a mike stand for announcements.

Friends are reminded to stay home if showing signs of illness, to wash hands thoroughly, and to let the Meeting know immediately if anyone in your broader community has been in contact with an infected person.

**Pre-nominating committee:** Esther Schiedel is the second nomination to serve on Nominating Committee, term March 2020 - Dec. 2022.

Meeting *approved* her serving on that committee.

**House and Hospitality:** Abigail Stoughton and Nancy Ewald reported that Work Unlimited—the organization that used to clean the Meetinghouse—has cancelled our service. They propose hiring two people who formerly worked for that company and who are familiar with the Meetinghouse cleaning regime. Meeting approved our hiring CleanTeam. After some discussion about options for access to Meetinghouse keys, we approved providing keys to these individuals. Nancy and Abigail will contact Sid Rosen about this. Abigail has purchased cleaning supplies designated for the CleanTeam. These will be clearly marked and stored in the closet.

**Groundskeeping** report will be held over until next month.

**Adult Religious Exploration:** programs have been scheduled for the coming weeks.

**Children and Youth Program:** The program, has for the most part, five children who attend. The children are engaged in reading books together, cultivating conversation and opinions of their own about various issues. We read about Thoreau and discussed resistance and taxes; learned about various communities of the world who grow and eat rice; made animal collages; learned about FCNL; created a vision for the world; performed plays.

The vision for the children's program remains the same: to educate, inspire, and nurture, and testify what/how we want to see in the world as it relates to our Quaker ways. As we approach spring the children will begin stepping outside and engage with the environment and our neighbors. Fun times ahead!

At the memorial yesterday, one of the very young children who attended found a china tea set, broke one of the dishes and cut his hand. We had not planned on having childcare at the event (not being aware that young children would be in attendance). We decided that it would be a good idea to always arrange for childcare for similar

## Food Bank Needs

Corvallis Friends continue to support local food banks as those services adapt to the needs and requirements resulting from the COVID-19 crisis. Last week, Nancy Ewald and I divided and delivered a case (10 boxes of 144 each) of toothbrushes, purchased by Corvallis Friends, to the South Corvallis Food Bank and St. Vincent de Paul (the north Corvallis food bank). Both volunteers and guests expressed enthusiastic appreciation.

The food banks are operating regular hours, following guidelines to keep everyone safe. Linn-Benton Food Share, which provides goods to all food banks in the two counties, is going above and beyond to help, as well. St Vincent de Paul requests that cash donations be sent to Linn-Benton Food Share at PO Box 1920, Corvallis, 97339. South Corvallis Food Bank urges the same, or checks may be sent to SCFB directly at 1750 SW 3rd St., Corvallis, 97333.

## Stone Soup Update from Beit Am

The community 'management' team for Stone Soup has reshaped Stone Soup in response to COVID-19.

Our next Beit Am/Friends collaborative meal is April 9.

1. They have asked that no one over 60 yrs work Stone Soup. The challenge is that perhaps 95% of the existing volunteers is older than 60, and many have compromised medical conditions.

2. The logistic operation of Stone Soup has changed: patrons will line up outside the door and will be required to wash their hands at an outdoor hand washing station, which is staffed by area youth; patrons then enter the dining room one at a time, pick up a meal to go, a drink to go...and then out the door.

Valley Catering is taking care of food production and packaging. Valley delivers meals to the kitchen.

With this reduced logistical demand, Stone Soup needs just THREE volunteers: one to cart the meals to the serving table; one to sit at the table; and a third who at the drink table. One of the volunteers is designated the 'lead', who also makes sure the door is unlocked at the start and locked at the end, etc.

Our meal next week, April 9, has three volunteers, considerably younger than 60 and in good health, who will manage this meal.

**I hope to continue calls to the Beit Am community and Friends...to its young adults to help out since the pandemic may continue for months.**

How can you help? If you know someone in their 20s or 30s with no compromising conditions, someone who would want very much to help out, they can contact me (Ken) and I'll connect them with the Stone Soup volunteer coordinator.
